

Cases filed under or converted to Chapter 13 on October 1, 2011, and thereafter.

Cases filed under or converted to Chapter 13 on October 1, 2011, will be assigned to either Doug Kiel or Sally Zeman, depending on the county of residence or principal place of business as designated on the Petition. Please see chart below for county and trustee designation.

Transfer of existing Sally Zeman cases.

Generally, the plan is to transfer Sally Zeman's caseload in the above designated counties to Doug Kiel over 6 to 9 months, in three stages:

Stage 1 - October 2011

Transfer of cases in the Colorado Springs/Pueblo 341 meeting counties with plans confirmed on or before September 15, 2011 (except for cases in which Sally Zeman has filed a notice of completion).

Stage 2 - January 2012

Transfer of cases in Doug Kiel's Denver counties confirmed before X date (TBD) (except for cases in which Sally Zeman has filed a notice of completion).

Stage 3 - April 2012

Transfer of remaining cases in all Doug Kiel counties (except for cases in which Sally Zeman has filed a notice of completion). This should capture those cases which were filed prior to October 1, but which were not confirmed before the stage 1 and 2 transfers, plus pick up any random cases previously not assigned.

Assignment of New Trustee.

The Court will assist effectuating this plan through entry of a GPO providing substantially the following provisions:

Reassignment of trustee: Based on a specific case designation list on file with the Clerk of the Court' office, a virtual text docket entry will be entered to effectuate the resignation of Sally Zeman and the reassignment of the case to Doug Kiel.

Existing wage orders in reassigned cases: For applicable cases, the Clerk of Court will be authorized and directed to issue an amended wage order to the debtor's employer directing that those wages or earnings be sent to Doug Kiel, Chapter 13 Trustee, P.O. Box 2282, Memphis, TN 38101-2282

Successor trustee report: Subject to further order of the Court in any particular case, Doug Kiel shall have until the later of the filing of the final report to incorporate the report of Successor Trustee to the extent otherwise required by Rule 2012(b).
